CLASS #6 - 8-10 fences, maximum 3'0" in height.

CLASS #7 - 8-10 fences maximum 3'3" in height.

CLASS #8 - 8-10 fences maximum 3'6" in height

All classes: Table II. Time taken first jump off over a shortened course immediately following clear round.

Extra schooling rounds \$5.00 each, but only 1<sup>st</sup> round to count toward ribbon.

PRACTICE FENCES MAY BE JUMPED IN ONE DIRECTION ONLY - red marker on right, white marker on left.
