DRESSAGE: *GRASSHOPPER:* USEF 2010 Beginner Novice Test A
BEG/NOV: USEF 2010 Beginner Novice Test B
NOVICE: USEF 2010 Novice Test B

CROSS-COUNTRY: *GRASSHOPPER:* Approximately 10 fences up to 2', approximately 1000 meters. Not timed.
BEG/NOV: Approximately 14 fences up to 2'7". 325 m/min.
NOVICE: Approximately 16 fences up to 2'11". 350 m/min.
Cross Country to be judged by the honor system. Spotters for help in scoring and safety.

STADIUM JUMPING: *GRASSHOPPER:* No more than 10 jumping efforts, fences up to 20". Not timed.
BEG/NOV: No more than 11 jumping efforts, fences up to 2'7" 300 m/min..
NOVICE: No more than 11 jumping efforts, fences up to 2'11" 320 m/min.

Entry Fee: \$85.00 Entries close (must be postmarked) two weeks before the event (February 18th).
If scheduling allows, a post entry fee of \$10.00 will be charged for late entries. *Refund, less office fee, after closing date, if place can be filled. Please call with any scratches.*

Awards: 8 ribbons per division

Time Schedule: Ride times will be posted on the www.tamarackhill.com website by 9:00 pm February 29th.

Horse Trials Policies: Tamarack Schooling Horse Trials follow the rules of the United States Eventing Association. Rules and applications for USEA membership may be obtained through their website, www.useventing.com.

1. Proper headgear is required at all times when mounted.
2. Medical cards must be carried whenever mounted.
3. Protective vests are required on XC.
4. No unauthorized assistance on the courses at any time.

Directions: From Rt.1, turn onto Youngs Rd. Go 2 miles. Turn right onto Tamarack Lane. Trailer parking is on left.
PLEASE NO DOGS, but if necessary, they must be leashed.
